CONTRIBUTIONS

Employer Contributions:

5% to 22% of the member's monthly basic salary.

Employer Contributions:

5% to 9% of the member's monthly basic salary

MEMBER'S FUND CREDIT CALCULATION:

Own Contributions + Employer Contributions – Risk Benefits and Admin Costs + Interest and Investment Returns.
